ENSP 421 - Seminar Resource Issues American West: Western Landscape History & Mgmt. / F / 9-11:40 a.m. This class takes its inspiration from the *High Country News*, an excellent newspaper covering environmental issues in the American West. But instead of just reading the paper, we will be asking, WHY are these issues so particular to the American West, and how did it get to be this way? We will take a historical look at the settlement, development, and management of the western landscape, both in terms of natural resources (timber, water, grazing, parks etc.) but also in terms of cultural settlement and use – and will consider how landscape can be used as a tool for understanding the cultural/social/political history of a place. The class will be reading-intensive, meeting once a week in a seminar style.
